BACKGROUND:

Once per year, the PHA must give each family the opportunity to choose between one of two methods for determination of the amount of tenant rent payable monthly by the family. The family may choose to pay either an income-based rent or a flat rent which is generally based on 80% of the fair market rents established by HUD annually less the utility allowance for that property. Except for financial hardship cases, the family may not be offered this choice more than once a year. The LHA currently has 24 families paying flat rent.
